However, a number of long term animal studies and human epidemiology studies evaluating TiO<sub>2</sub> and workplace exposure show insufficient evidence for carcinogenic effects. EPA, NTP and OSHA do not designate TiO<sub>2</sub> as a carcinogen and ACGIH designates TiO<sub>2</sub> as A4 - not classifiable as a human carcinogen. TiO<sub>2</sub> is not present in this product as a dust and no airborne exposure is expected during application. This product contains methylpolysiloxanes which can generate formaldehyde at approximately 300 degrees F (150 C) and above, in atmospheres which contain oxygen. Formaldehyde is a skin and respiratory sensitizer, eye and throat irritant, acute toxicant, and known cancer hazard.
