



# 2019 OTC Sweepstakes

## Official Rules and Regulations

Please read the Official Rules and Regulations (“Official Rules”) of the LORD Corporation (“LORD”) 2019 OTC Sweepstakes (“Sweepstakes”). You must agree to accept and comply with the Official Rules to in order to participate in the Sweepstakes.

**Sweepstakes Period:** Entries will be accepted starting at 10:00 am on Monday, May 6, 2019 and ending at 2:00 pm on Thursday, May 9, 2019.

**How to Enter:** The Sweepstakes must be entered by submitting an entry at Booth # 2867. The entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the LORD Corporation.
